



The Use of Cash and Voucher Assistance in Humanitarian Programmes to Promote the Well-Being of Crisis-Affected Adolescents

Resources for Practitioners

Cash and Voucher Assistance (CVA) has gained momentum as a viable conduit in humanitarian settings to provide adolescent-responsive programming supporting their protection, education, and well-being. The resources shared below were developed by <u>Plan International</u> and the <u>Women's Refugee Commission</u> (WRC), with support from the Swedish International Development Cooperation Agency (SIDA), to help practitioners effectively use CVA to achieve protection, education, and well-being outcomes for crisis-affected adolescent girls and boys (10–19 years).

Guidance and tools for the assessment, design, implementation, monitoring, and evaluation of CVA integrated into adolescent-responsive programming that promotes the protection, education, and well-being of adolescent girls and boys in humanitarian action. They are designed for Plan's programming around the world and are aligned with its <u>CVA Programming Step-by-Step Guideline</u> and <u>Adolescent Programming</u>. <u>Toolkit</u> as well as best practice resources, including the CaLP Network's <u>Programme Quality Toolbox</u>. These resources can be used by any organisation and are easily contextualised as they have been technically validated through pre-testing in selected Plan country offices and through inter-agency review.

What is the purpose of the guidance and tools? These resources are designed to support cash and sectoral practitioners' work to ensure that adolescent-responsive programming integrates CVA as appropriate and comprehensively meets the needs and enhances the capacities of diverse adolescents affected by crisis.

Where and when should the guidance and tools be used? These resources should be used in all humanitarian settings where CVA is deemed appropriate and feasible. They are ideal for the design phase of the programme cycle to ensure quality programming. The resources are organised in "mini guides" and are linked to corresponding tools for each phase of the programme cycle.

How should the guidance and tools be used? All the resources are designed to be adapted to context and are modular so that cash and sectoral actors delivering adolescent-responsive programming can work together to bridge gaps in current practice.

Cash and Voucher Assistance for Adolescents: An evidence review of how cash and voucher assistance can achieve outcomes for adolescents in humanitarian settings

This is a <u>literature review</u> on adolescent-focused programming from various sectors such as protection, education, sexual and reproductive health (SRH), food security, and livelihoods to support sectoral and cross-sectoral outcomes. It allows for the design of evidence-based programming by sharing insights on the best approach to prioritize ongoing evidence gaps on adolescent programming within the humanitarian architecture.
