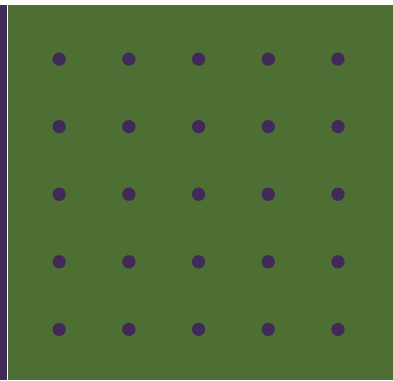

The Coalition

The coalition to End Violence Against Women and Girls globally consists of more than 180 U.S.-based organizations whose combined expertise, experience, programmatic work, and collaboration with local activists make it a powerful resource on preventing and responding to gender-based violence globally.

Through education, advocacy, and collaboration, the coalition works together and with the U.S. Government to build lasting solutions to end violence against women and girls globally. We hold governments including the U.S. accountable for upholding the rights of women and girls.

- Implement programming, support, and direct services for local organizations and individuals
- Conduct fact-based research, analysis and reporting
- Integrate GBV support in development efforts, policy, and emergency relief
- Provide resources, toolkits and trainings that promote best practices

70% of women in emergency settings will experience some form of gender-based violence. (2)

Only **.12%** of all humanitarian funding goes to preventing and responding to GBV. (3)

Coalition Priorities for 2023

Implementation of the US Government Strategy to Prevent and Respond to Gender-Based Violence Globally - 2022

- Consult and collaborate on the implementation of the GBV Strategy and the 2021 National Strategy on Gender Equity and Equality.
- Strengthen ongoing communication and consultations during the development of the Strategy's implementation plans

FY 2024 Funding for Gender Equality

- Call on Congress but to fully invest in funding to prevent and respond to GBV at \$414 million in the FY2024 State, Foreign Operations and Related Programs Appropriations bill and Committee report.
- Call on the President to invest at least \$3.45 billion for global gender equality in the Fiscal Year 2024 budget request.

Safe from the Start Act

- Pass the Safe from the Start Act, legislation that would advance policy solutions that address GBV in Humanitarian Emergencies and improve the ability of those who work in emergencies to adequately prevent and respond to GBV from the onset of a crisis.

International Violence Against Women Act

- Advance policy solutions which would make ending violence against women and girls a top diplomatic, development, and foreign assistance priority.
